TERMS & CONDITIONS USE OF BOAT / PONTOON / WAVERUNNER

liability to third parties – The undersigned hereby agrees that he/she will indemnify and hold harmless Columbia River Boat Rental, for all personal injuries, property damages, or any other damages to any and all third parties, including but not limited to, operators and passengers of other watercraft and minor children under the undersigned's custody, care, and control as a result of any and all activities related to the rental, operation, or use of equipment provided by CRBR, even if such damages arise out of the negligence or fault of Columbia River Boat Rental, LLC.

express assumption of risk- The undersigned hereby agrees that he/she is renting, operating or using the equipment provided by Columbia River Boat Rental, LLC at his/her own risk. The undersigned agrees that he/she is voluntarily participating in all activities related to the rental, operation, or use of the rental equipment. The undersigned assumes full responsibility for the risks of personal injury, accidents or illness, including but not limited to sprains, torn muscles and/or ligaments; fracture or broken bones; eye damage; cuts, wounds, scrapes, abrasions, and/or contusions; head, neck, and/or spinal injuries; animal or insect bite or attack; shock, paralysis, drowning, and/or death; and any resultant expenses from any of the foregoing risks and assumes all risk injury, illness, damage or loss that might result, regardless of the cause, even if the risks arise out of the negligence or fault of Columbia River Boat Rental, LLC.

Renter further agrees (a) that the rented boat shall not be used to carry passengers or property for hire; (b) that the rented boat shall not be used to carry passengers or property in excess of the rated capacity of the boat; (c) not to use the boat to tow or propel any other boat, barge or thing without the owner's written permission; (d) to report any problems or issues immediately to renter; (e) not to use the boat (or motor) for any illegal purpose; (f) not to operate the boat (or motor) in a negligent matter; (g) not to operate the boat (or motor) outside the area of use designated in this Agreement; (h) not to permit the boat (or motor) to be operated by any other person without written permission of the Owner; and (i) not to remove the motor from the boat for any use what so ever, (j) that he/she has been properly instructed and is confident to operate said boat.

The renter further agrees to use Credit Card as security deposit with the Owner, said deposit to be used as in the event of loss of or damage to the boat or equipment or motor or trailer during the term of this Boat Rental Agreement. In the event of damage or loss renter agrees to be charged directly to Credit Card on file for the remaining balance to cover damages, repairs or loss of equipment.

Renter hereby agrees that he/she shall fully indemnify & release Owner from claims, demands, losses, damages, actions and expense related to the use of boat. The Renter hereby agrees that he/she shall be held fully responsible for any and all loss of or damage to the boat or equipment or motor or trailer during the term of this Boat Rental Agreement whether caused by collision, fire, flood, vandalism, theft or any other cause. RENTER agrees to pay the cost of repairing damages to, and any collection, court cost and / attorney fees necessary to secure reimbursement.

THE RENTER CERTIFIES THAT HE/SHE HAS EXAMINED THE CRAFT AND EQUIPMENT AND FINDS IT ACCEPTABLE AND SUITABLE FOR THE PURPOSE FOR WHICH IT IS LEASED. THAT HE/SHE WILL OPERATE THE CRAFT IN ACCORDANCE WITH ALL SAFETY RULES AND REGULATIONS.

In the event of malfunction, breakdown, or if any defect is discovered after acceptance of the rental craft the RENTER will immediately report it to OWNER.
