Please be prepared to sign a lease within <u>2-3 BUSINESS DAYS</u> of your <u>APPROVED</u> application IF YOUR APPLICATION IS NOT COMPLETED WITHIN 2 DAYS, THE APARTMENT MAY BE PUT BACK ON THE MARKET

### DOCUMENTS NEEDED: Photo I.D. required for each applicant (please do not fax)

#### A - IF YOU WORK FOR A COMPANY:

- Employment Letter on Employer's letterhead verifying <u>length of employment</u> and <u>annual income for past 2 years</u> (include any bonus, rental allowance or other extra income)
- Copy of your most recent pay stub
- If employed less than 2 years, prior W2, tax return or employment letter from your prior employer
- Three (3) most recent bank statements
- Letter of reference from your prior landlord or cancelled rent checks for past 2 months

#### B – IF YOU ARE SELF-EMPLOYED OR COMMISSION-BASED:

- Letter from your accountant verifying length of employment, type of business and annual income for past 2 years
- Copy of your complete federal income tax return for the past 2 years (including all schedules, W2 & 1099 forms
- Three (3) most recent bank statements
- Letter of reference from your landlord

#### C – GUARANTOR REQUIREMENTS (at lease Monthly Rent x 80)

- All items listed in A or B above

#### D – CORPORATE LEASE WITH PERSONAL GUARANTOR:

- Copy of an income statement and balance sheet or Annual Report
- Letter of reference from the prior landlord of the occupant or company if the company has previously rented an apartment
- A corporate resolution
- A personal guarantor (see item C above)

You will be required to deliver to the Leasing Office two (2) separate checks, bank checks or money orders – one for the first month rent and the other for the security deposit.
